- Photocopy proof of Applicant's PAL/Minor's PAL(Proof that application is in process with Chief Firearms Officer.)
- Photocopy proof of parent/guardian PAL (where applicable)
- Photocopy proof of applicant's membership to Biathlon Manitoba for the 2025/2026 season
- Cheque or eTransfer to Biathlon Manitoba for Rifle Rental
(eTransfer: biathlon@sportmanitoba.ca)
- Initialed acknowledgement of the following points:
- Attend a BAM Cleaning and maintenance clinic
- Clean the rifle before returning to the Armourer at the end of the rental period

- Return the rented rifle to the Armourer by Mar 31 of the rental year. Failure to do so will result in forfeiture of deposit.
- Maintain the rented rifle and accessories in the condition received at time of rental. Failure to do so will result in forfeiture of deposit as well as any restorative costs incurred, above the amount of the deposit (up to \$250).
- Disclose any repairs made to the rented rifle, to the armourer.
- Pay, to BAM, the listed replacement cost of their rented rifle and accessories if they cannot be returned (due to loss, theft, damage, etc.).
